INSTRUCTIONS FOR CONSIGNMENTS

SENT WITH CZECH POST

Following are simple instructions on **how to label** certain types of consignments sent with Czech Post **by contractual partners**. The document contains recommended address formats and a link for downloading Czech Post's logo to identify the operator used to send the consignment.

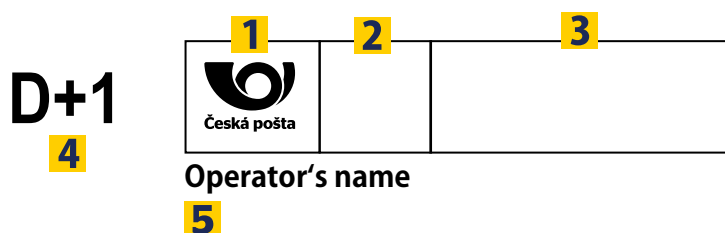

ADDRESS SIDE LABELLING INSTRUCTIONS FOR consignments sent with Czech Post

LABELLING FIELDS



Framed fields for:

1. identification of the operator delivering the consignment (Czech Post's logo)
2. product code
3. user's ID (CČK file ID)

Unframed field for:

4. D+1 for priority mail identification
5. Operator's name (only for consignments sent under the Contract to Provide Access to Special Services and Postal Infrastructure Elements)

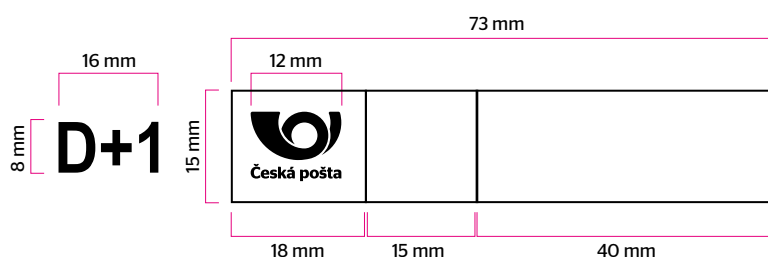
LABEL SPECIFICATIONS

Frame size

Recommended size: **73 x 15 mm**.

Minimum size: **50 x 10 mm**.

Logo width for recommended size: **12 mm**.



Colour

Black or blue (CMYK 100/85/5/22 or Pantone 280C including similar shades).

Font

Sans serif (e.g. Arial, Helvetica – font size 11 points).

Czech Post's logo

Different formats of Czech Post's logo can be [downloader](#) from its website in the Download/Logo to download section.

D+1 symbol size

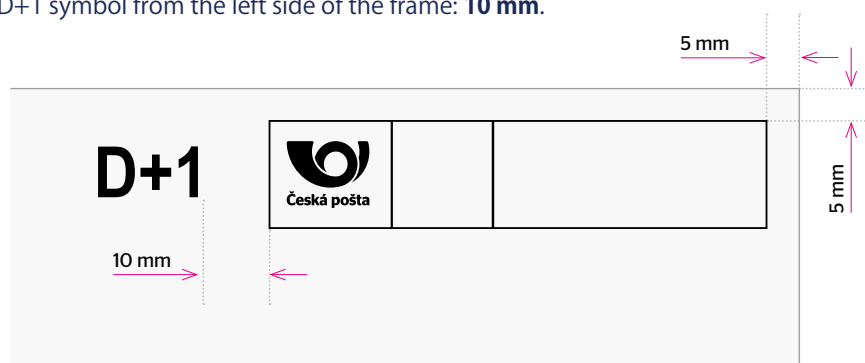
Recommended D+1 symbol size: **16 x 8 mm**.

Position of the frame and the D+1 symbol

The frame must be positioned in the upper right-hand corner of the address side.

Recommended distance of the frame from the envelope's side: **5 mm**.

Recommended distance of the D+1 symbol from the left side of the frame: **10 mm**.

COMPULSORY ELEMENTS OF THE RIGHT FIELD



DOMESTIC CONSIGNMENTS

The **right field** of the frame must contain the allocated **user's ID** (CČK file ID*).

The postcode and name of the posting post office; the identifiers P.P.; T.P.; TAXE PERÇUE and CZECH REPUBLIC and their combinations are also acceptable.

INTERNATIONAL CONSIGNMENTS

The **right field** of the frame must contain the allocated **user's ID** (CČK file ID) plus the identifiers P.P. and CZECH REPUBLIC.

T.P. or TAXE PERÇUE may be used instead of P.P.

DOMESTIC CONSIGNMENTS

Compulsory elements of Reply Mail consignments: the allocated ID (CČK file ID) of the user, i.e. the Reply Mail consignment's addressee plus the note "ODPOVĚDNÍ ZÁSILKA CENU HRADÍ ADRESÁT" ("REPLY MAIL PAYABLE BY THE ADDRESSEE").



INTERNATIONAL CONSIGNMENTS

The address side must contain the following details:

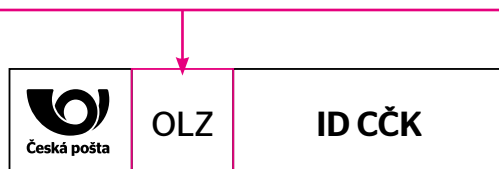
- A postage stamp symbol, crossed diagonally from the upper left-hand corner to the lower right-hand corner, must be located in the upper right-hand corner of the address side, which must be superposed with the following text written in capital letters: "NE PAS AFFRANCHIR," accompanied by a Czech translation of this note, i.e. "NEVYPLÁCET;"
- Two horizontal lines at least 3 mm thick, spaced apart by min. 14 mm, must be printed above the addressee's address. 14 mm. Between the lines, the following text must be printed in capital letters in two lines:
RÉPONSE PAYÉE/ODPOVĚDNÍ ZÁSILKA
RÉPUBLIQUE TCHÈQUE/ČESKÁ REPUBLIKA
The text may be followed by a slash and a translation of this text in the language of the country from which the consignments will be arriving.
- The note or label "Prioritaire/Par avion" (does not apply to economic consignments) has to be located in the upper left-hand corner, with the CCRI/IBRS designation and the allocated user's (CČK file ID) below it;

The address may not be stamped, typewritten or handwritten.

COMPULSORY ELEMENTS OF THE MIDDLE FIELD



The **middle field** of the frame must contain the **product code**. The delivery time symbol "D+4" must also be added on International Commercial Letter consignments..

COMPULSORY ELEMENTS OF THE LEFT FIELD



The left field of the frame must contain the Czech Post's logo. The note "DODÁVÁ" ("DELIVERED BY") above the Czech Post's logo must also be added on consignments sent under the Contract to Provide Access to Special Services and Postal Infrastructure Elements.

PERMITTED EXCEPTIONS

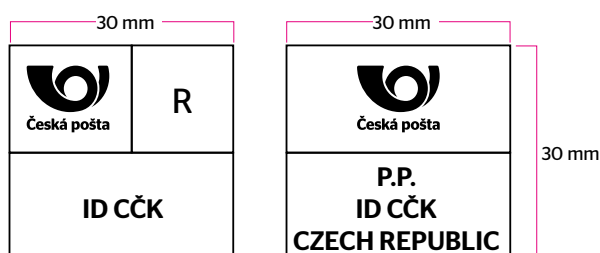
Czech Post's logo replacement

Subject to Czech Post's consent after prior consultation, the logo may be replaced by the verbal identifier "ČESKÁ POŠTA" ("CZECH POST") in exceptional cases when printing on specific materials (such as foil) is used in PostServis centres.



Alternative frame format for letters sent in a special envelope containing a return receipt form

Subject to Czech Post's consent after prior consultation, an alternative frame format with rearranged fields with or without product code may be used in exceptional cases when printing on special envelopes containing a return receipt form is used. This exception does not concern the content of the fields.



Format without product code

The use of product code is not required for the following products: Ordinary Letter, International Ordinary Mail, any domestic or international consignments whose recorded consignment ID (barcode) contains the product code.

LABELLING FORMATS FOR RIM (DISTRIBUTION OF INFORMATION MATERIALS) CONSIGNMENTS

RIM – labelling of packs (bundles) of leaflets

If Credit is the selected payment method, the User's ID (CČK file ID) is the number of the Credit used to pay for the RIM (Distribution of Information Materials) consignment.
